2022 brought EJTN back to the 'new normality'. After a long pandemic with many last minute changes and adaptations, training activities once again became plannable. The essence of the European Judicial Training Network's (EJTN's) training activities is to build and deepen mutual trust by bringing together judges and prosecutors from all over Europe, to enable them to meet in a protected physical space to discuss legal and other issues face-to-face. This became possible again in 2022. Still, we have learned a great deal in the three years that have just passed. Our training offer is much broader than it used to be before. We have many new online activities, such as the fortnightly lunchtime webinars and the online conversation classes in five languages.

As usual, the EJTN 2023 offering is designed to address the interests and needs of European judges, prosecutors, judicial trainees and trainers from across Europe regarding training on EU law, the Rule of Law, judgecraft, training methodologies, linguistics and societal issues. Most of our training activities will be open to court staff.

EJTN's activities are the outcome of the cumulative efforts of EJTN's members, encompassing all national training institutions from all 27 EU Member States, including national court staff training providers and the Academy of European Law (ERA), with the objective of shaping the future of European judiciaries. They are built on an extensive training needs analysis encompassing an evaluation of the past events. These needs are expressed by EJTN's members, participants of EJTN's activities, numerous

partner organizations, including judicial networks and associations, as well as European institutions and EU Council Presidencies.

We are grateful to everyone involved in the development and implementation of EJTN's activities: EJTN's member institutions, the Working Group Programmes and the members of its four Sub-Working Groups, the members of the Working Group Judicial Training Methods and Working Group Linguistics, and all their conveners, activity coordinators, experts and project managers of the EJTN Secretariat.

We are presenting here an overview of EJTN's extensive range of training activities, as well as information on how, when and where to apply. We encourage everyone to take part in the seminars presented, as well as other training opportunities, and to further disseminate information about EJTN's training activities.

This calendar also presents EJTN's database of materials and resources, and the English language self-test. Reference is also made in the publication to the EJTN lunchtime webinars and the recently launched online conversation classes in five languages.

Please note that the EJTN flagship activity, the Exchange Programme, is not presented in this calendar

Finally, we would like to express our thanks to the European Commission for its financial support for the EJTN, which made it possible to offer such a rich array of judicial training opportunities.

ONLINE CONVERSATIONAL CLASSES

The EJTN has completed the pilot project of online conversational classes. The series of six 1-hour weekly online classes started in 2021, continued in 2022 and the EJTN will repeat the series in 2023. Participants can join one of the ten classes offered in various languages: English, French, German, Italian and Spanish. Several classes are held in English, some for participants at an intermediate (B1) language level and some for those at an upper intermediate (B2) language level. French, German, Italian and Spanish classes are intended for participants at an upper-

intermediate (B2) language level.

The series helps participants improve their speech skills in the target language while also learning important legal terminology. Each class consists of 8–10 participants to maximise interaction between them. The project is conceived to improve the legal language skills of the participants and therefore prepare them for participation in any of the EJTN's numerous activities.


The next series of classes will be held in Spring 2023. The exact dates will be announced in due course.

EJTN has prepared blended learning modules for training seminars within its linguistics and criminal justice portfolios with the help of expert virtual learning consultants.




An online English language level test is available on the EJTN website: learning.ejtn.eu/login


